MINUTES of the REGULAR MEETING of the BOARD OF TRUSTEES of the PEMBER LIBRARY & MUSEU March 17, 2022

The Regular Meeting of the Board of Trustees of the Pember Library & Museum was held on March 17, 2022, at the Pember Building, located on West Main Street in Granville, NY.

The meeting was called to order by President Mary King at 6:02 p.m. The following Trustees, constituting a quorum, were present: Mary King (President); Murray McHugh (Vice President); Jerry McKinney (Secretary); Robert Tatko (Treasurer); George Demas; Maria Hyatt; Rob McGuire; Gigi Zeitler. The following Trustees were excused: Nancy Labate Bixby.

The following staff members were present: Kristen DeSantis (Library staff); Bernadette Hoffman (Museum Educator).

The representative from the Village of Granville Board of Trustees, Dan Brown, was present.

The following members of the public were present: none.

The agenda was adopted.

The minutes of the regular meeting held on February 17, 2022, were approved.

The **Financial Report**, prepared by Treasurer Robert Tatko, was received.

 \rightarrow All accounts are in good order. The Pember has no debt.

→ The Board acted to authorize the Treasurer to pay all Library & Museum bills through April, 2022.

The **Library Report**, prepared by Kristen DeSantis, was received and discussed. [*Report attached*.]

 \rightarrow The first "pop up" meal will be held on the second Thursday of April.

 \rightarrow Mary King will check with SALS about language concerning elimination of fines.

The **Museum Report**, prepared by Museum Educator Bernadette Hoffman, was received and discussed. [*Report attached*.]

 \rightarrow A person will be hired to clear trails at the Hebron Preserve.

→ Show-And-Tell: The Museum Educator showed the Board sandpiper eggs that were part of five sets of eggs sent by Arthur E. Price to Mr. Pember; and a remnant of a Grey Goose Tobacco box dating from the 1890s.

The Liaison Report was made by Murray McHugh and Nancy Bixby, Pember liasisons to the Village Board, and Village Trustee Dan Brown.

- → The liaisons reported on the chimney repair discussion with the Village Trustees. The Board discussed this issue at some length. The consensus of the Board was: (a) If at all possible, the current chimney and roof line should be repaired and kept intact; (b) The Board would have the chimney inspected by a qualified person(s); (c) The historical status of the Pember Building would need to be determined. The Board will make a decision regarding this matter at the April meeting, if possible.
- →Fixing the front porch drainage problem and paving the parking lot are ongoing projects for the Village Board.
- → The Board expressed its thanks to Village Trustee Dan Brown for his work on these important issues; and its thanks to Murray McHugh and Nancy Bixby for their work as liaisons with the Village Board.
